Then there is the issue of the ballots identifying party on the outside of the envelope by either a red or blue design.

I have also seen the video of how ballots were processed in the Whatcom County Election Center. There was only one person per table when there should be at least two. There was a woman who was marking ballots. It appeared that she crossed out a name and drew in a new bubble. There was no oversight. There were no checks and balances. There was no accountability. The persons who were supposed to be watching were playing on their phones, in another area completely.

One area that I would like clarity on is the ballots that had a write in nomination for lieutenant governor of Joshua Freed. I believe that these ballots were placed aside for arbitration. I believe that these ballots were taken out of the chain of custody.

I have seen other reports, that I do not have in my possession, of ballot numbers in Whatcom County being changed in the favor of the democrat party.

I believe that actions need to be taken to secure and validify the chain of custody for all future elections. What we have right now leads to too many areas where chain of custody and accountability has been broken. Having an audit to see where the issues reside is the best choice moving forward for all citizens of Whatcom County and Washington State. This way we have a base line and can improve the chain of custody as well as the ballots themselves. This makes it so any and all elections in the future have clear signatures of every person involved with processing the ballots as well as images of the ballot received for the voter to be able to verify online or in person.


