AG BOB FERGUSON MAKES FALSE ALLEGATION OF BASELESS LAWSUITS WASHINGTON STATE NON PROFIT HITS BACK WITH VERIFIABLE FACTS

On Wednesday, June 1st, 2022, Attorney General Bob Ferguson tweeted a statement regarding 28k in sanctions that was imposed on WEiCU and its attorney over one month ago in a motion hearing in the Supreme Court. The Writ of Mandamus petition was filed against Governor Inslee to uphold his Constitutional oath to ensure only qualified electors are registered to vote per Article 6, Sec. 1 of our Washington Constitution. The Department of Licensing, an Executive Branch agency under Inslee's oversight, violates this Article every time an unqualified voter is registered at the Department of Licensing.

AG Ferguson incorrectly stated that WEiCU's entirely different eight lawsuits filed in eight different counties were dismissed as 'frivolous' while all eight are still pending. A lawsuit filed in Lincoln County is pending on appeal while a lawsuit filed in Franklin County was revived by Judge Knodell on May 25, 2022 when he signed an order granting WEiCU leave to file a Second Amended Verified Complaint (Motion to Show Cause). A hearing on why Franklin County should not have to show cause why it is not able to produce the ballots for inspection is scheduled for Monday June 6, 2022. The remaining six cases are in Federal Court and have been waiting for six months for the presiding Judge to rule on Perkins Coie's Motion to Intervene as a Defendant on behalf of the Democratic Central Committee, among other pending motions. Joe Kent, Clark County Plaintiff and WA CD 3 candidate says, "This tyrant and his lackeys are trying to intimidate citizens from demanding transparent elections." Doug Basler, King County Plaintiff and WA CD 9 candidate says, "What are they hiding? All we are asking is to see the ballots."

Both AG Ferguson and Governor Inslee made similar comments on social media stating, "Attorneys and organizations who attack our democracy and abuse our legal system must face accountability. We will continue fighting to protect our elections from these baseless lawsuits that push 'the big lie'." Tamborine Borrelli, WEiCU's Director says, 'This is more of the same abuse of power and overreach into our judicial system where evidence is ignored while under threat of character assassination and financial ruin. Dismissing procedural Public Records Request complaints as baseless is statutorily incorrect, not being based on merit but on political agenda is the biggest threat to our way of life and our Constitutional Republic."

WEiCU submitted verifiable evidence to the Supreme Court Commissioner, obtained from publicly available data (video on WEiCU.org home page) of the non citizens registered to vote and redacted names of ballots 'accepted' along with an account of a 19 year retired DOL employee who substantiated their claim. This evidence was not considered nor was it investigated.
